The **Meghalaya State Agricultural Marketing Board (MSAMB)** invites **Co-operative societies, IVCS, PACs, FPC, FPO, VDVK and other Interested Entities** to submit Expression of Interest (EOI) for availing **godown facilities** located at the **Garobadha Wholesale Market, South West Garo Hills**.

Objective

The MSAMB aims to support local farming communities by providing accessible, well-maintained godown facilities for the storage of agricultural produce. This initiative is intended to enhance post-harvest management, reduce storage losses, and promote the economic growth of local farmer groups and cooperative societies.

Key Features of the Godowns:

- **Location:** Garobadha Wholesale Market, South West Garo Hills, Meghalaya
- **Number of godowns: 2 with storage Capacity: 1000 MT each with an area 560 sqm each.**

- **Tenure:** The go down facility shall be provided free of cost for a period of 1 year.

4. The applicant must demonstrate financial capability to manage the godown effectively.
